Terms and Conditions

1. Vehicle Description. A description of the Vehicle is set forth above and on Schedules 1 and 2 attached hereto and made a part hereof. The Vehicle(s) being offered are in older and/or used condition and are not perfect. Not all flaws in the Vehicle can be listed. All Vehicle descriptions/statements printed in SYA ads, showroom listings and auction descriptions, as well as verbal statements made by the auctioneer or agents, have been provided directly from Seller. SYA will attempt to obtain all answers to any questions you may have. SYA provides Seller's listing information only and, therefore, assumes no responsibility or liability for representations made by Seller and shall have no obligation to verify or authenticate such statements or claims; having assumed the authenticity of all information.

2. "As is" Sale. All Vehicles are sold "AS IS" at Seller's residence or storage facility with no warranties or guaranties of any type, express or implied, made by SYA. Any warranties made by the Seller to Buyer must be in writing on an instrument separate from the Bill of Sale and signed by both the Buyer and the Seller. In no event shall SYA, its employees or agents or the auctioneer, be responsible or liable for such warranties, guarantees or the description of any Vehicle offered for sale by Seller.

3. Our Relationship. Under SYA's agreement with Seller, SYA acts as a disclosed agent for the Seller in pursuing the sale of Seller's Vehicle. SYA is not in possession of the Vehicle(s) offered or advertised. SYA is providing a service to the Seller by facilitating a sale and can only act for Seller while engaged by Seller. Sellers generally have the right to sell a Vehicle outright at any time, unless we state otherwise above. Generally the Vehicle is being offered for sale through many venues, which may include eBay Motors.

4. Exclusivity in Media. The Vehicle may be offered in other media (electronic, print, or otherwise) by the Seller. If it is not offered for sale in other media, SYA shall provide above that the Vehicle's listing is a "media exclusive." Seller shall promptly notify the SYA of any change in the offering status of the Vehicle at which time SYA shall advise a potential Buyer. Media exclusivity does not imply that SYA is the exclusive sales agent for the Vehicle.

5. Reserve Price. In some instances a Vehicle is offered subject to the reserve price determined by Seller. WE DO NOT GIVE OUT SELLER'S, RESERVE, so please do not ask.

6. Inspection. All Vehicles are offered with the right to a pre-purchase inspection before the transaction is finalized. SYA can arrange to have the Vehicle sent to a dealer or have a third party inspect the Vehicle on site for Buyer. Buyer may also personally inspect the Vehicle; send their own inspector or all of the above. Buyer is responsible for the cost of the inspection. Inspections must be done within Ten (10) calendar days, after the close of an auction or SYA's receipt of deposit monies from Buyer. Otherwise, it is assumed the Buyer has accepted the Vehicle without an inspection and the full Purchase Price will be due, including the "Deposit," as defined below.

7. Seller's and Buyer's Right to Cancel. The Seller may, at any time, remove the Vehicle for sale by SYA. If this occurs, we will delete the listing on our Website(s) or advise a potential Buyer and, if a deposit has been previously provided by Buyer, SYA shall immediately return Buyer's deposit as SYA's full obligation to Buyer. Under no circumstances will SYA be liable to a potential Buyer for any indirect, special, incidental, punitive, consequential, or other damages where Seller has decided not to sell a Vehicle, or Seller removes its Vehicle listing with SYA, for any reason. SYA reserves the right to end any eBay auction at any time for any reason.

8. Deposits and Refunds of Deposits. Buyer shall pay SYA a deposit of Five (5%) Percent (Deposit) of the final auction bid/Purchase Price, which must be paid within Seventy-two (72) hours to secure sale of the Vehicle prior to inspection. The Purchase Price is (_____) (\$ _____) DOLLARS. This Deposit will be refunded in the event Seller has previously sold the Vehicle or during the Ten (10) day inspection period described above, it is discovered that the Seller has materially misrepresented the Vehicle, which determination shall be made in SYA's sole discretion. Once the Vehicle is approved by the Buyer (or Ten (10) days have passed from the date of an auction or receipt of a Deposit), the Deposit becomes non-refundable and the remaining balance of the Purchase Price (Final Payment) must be paid directly to the Seller, or to SYA in escrow for Seller.

9. Payment. Deposits and Final Payments must be made by cashiers or certified check or wire transfer within a reasonable time frame as stated in the auction description or as mutually agreed to by SYA. Title for any Vehicle purchased may be withheld until Buyer's funds clear the Seller's or SYA's bank account. If you would like to pay by wire transfer, please contact SYA at 847.838.3749 for instructions. An additional fee will apply.

10. Delivery and Storage. All Vehicles shall be removed from the Seller's premises or storage facility by the Buyer at Buyer's expense following the sale within a time frame mutually agreed to by Buyer and Seller. If not so removed, Seller may store or remove the Vehicle with all costs of moving and storage to be paid by the Buyer. In that Vehicles are located at the Seller's home or storage facility, arranging transport of a Vehicle is Buyer's sole responsibility and cost. SYA will assist in arranging such transport service for an additional fee.

11. Severability. If any Paragraph or part thereof of this Agreement shall be held void or unenforceable, the validity of the remaining provisions shall not be affected.

12. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois, without regard to the principles of conflicts of laws. In the event of a dispute between the parties, the matter will be resolved by arbitration under the rules of the American Arbitration Association. Arbitrations shall be held in Chicago, unless otherwise agreed to by the parties. A single arbitrator shall be selected by the parties from the American Arbitration Association's list of available arbitrators. If the parties are unable to agree upon an arbitrator, the American Arbitration Association will designate an arbitrator. The costs of the arbitration fees will be paid for jointly by the parties.

13. Entire Agreement. This Agreement contains the entire understanding of the parties with respect to the subject matter hereof and supersedes all prior agreements or understandings, whether oral or written. This Agreement shall not be modified except in a writing signed by both parties hereto. No provision hereof shall be deemed waived by SYA, unless such waiver shall be in writing and signed by SYA or a duly authorized representative of SYA.

14. Notices. All notices shall be sent via personal delivery, with proof of receipt or by certified mail, return receipt requested, with a copy being sent on the same day by e-mail. Notices shall be deemed effective on the date of personal delivery or on the date of mailing for certified mail, whether accepted by the party to whom addressed or rejected.
